No. PMAS-AAUR/AC-59/25748 The Syndicate in its 80th meeting held on 30.06.2018, approved the following recommendations of 59th Meeting of Academic Council held on 07.03.2018:-

1. RELAXATION IN TUITION FEE FOR EMPLOYEES' CHILDREN IN DIFFERENT DEGREE PROGRAMMES AT PMAS-AAUR

The house after detailed discussion recommended the following criteria of fee concession for university employees and their dependents w.e.f. Fall Semester 2018:

Category of Employee	Fee Concession
Children of Employees BS-1 to 15	Subsidized fee of Rs. ²³⁰⁰ 2000/- per semester alongwith University securities (refundable)
Children of Employees BS-16 and above	Subsidized fee of Rs. ^{5700/-} 5000/- per semester alongwith University securities (refundable)
University Employee BS-1 to 15 (once only in service)	Subsidized fee of Rs. ²⁹⁰⁰ 2500/- per semester alongwith University securities (refundable)
University Employee BS-16 and above (once only in service)	Subsidized fee of Rs. ⁵⁷⁰⁰ 5000/- per semester alongwith University securities (refundable)

- i. The fee concession for improvement of qualification will be admissible only after completion of probation period.
- ii. The recommendations for admission must come from the department concerned.
- iii. The program of admission, preferably, should have relevance with the service/subject of the employee at the University.
- iv. The admission in such cases, however, should be strictly on merit.
- v. The degree/subject of interest must be related to the job responsibilities of the applicant.
- vi. Such training/qualifications should result into increased efficiency of an individual in the assigned job.
- vii. The faculty/staff members concerned should sign a bond to serve the University for 02 years for Masters and 05 years for Ph.D degree program or pay the total fee of the degree program with 10% annual interest.
- viii. The children of university employees will continue to avail fee concession facility till completion of their present degree program.

II. INCREASE IN REMUNERATION FOR CHECKING EXAMINATION PAPERS

The house recommended the following revised remuneration for checking examination papers for undergraduate and postgraduate degree courses w.e.f. Fall Semester 2018:

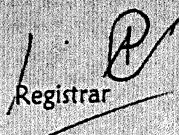
