The following recommendations regarding course load at different levels of National Qualifications Framework (NQF) are circulated again for implementation:

NQF Levels	Qualifications	Course load / Semester
Level – 05	Associate Degree	15 – 18 credit hours
Level – 06	BS & equivalent	15 – 18 credit hours
Level – 07	MS/MPhil & equivalent	09 – 12 credit hours
Level – 08	PhD	09 – 12 credit hours

Further the summer and winter session shall only be offered for the deficiency / repetition courses or internship.
